



THE BAROON POCKET CATCHMENT CARE GROUP

The public meeting to form a Baroon Pocket Catchment Care Group was held at the Community Centre on September 8th. The meeting was well attended, even though there were other meetings on in town at the same time. This meeting was a follow on from the initial workshop held at Solothurn, to which representatives from various community groups, including Barung Land Care were invited to attend.

The driving force behind the formation of a Baroon Pocket Catchment Care Group has been the Caloundra-Maroochy Waterboard, so that the central concern has been the water quality of Lake Baroon. The Waterboard has hired independent consultants, Sci-Plan, to facilitate the formation of a Catchment Care Group. While there are definite advantages in having an independent group that is not part of the local government bureaucracy or politics, there are also some disadvantages. There has been a lack of knowledge about local groups already working in the area, for example Barung Landcare. Some basic knowledge of local conditions has been lacking on the part of Sci-Plan - such as, that Maleny township is within the Baroon Pocket catchment.

There was much discussion about whether Barung should consolidate its work and broaden its community input to address the catchment issues of Baroon Pocket. Several people stated that the quality of water in Baroon Pocket reflects the health of the land through which the Obi flows. Dean Cameron, Peter Oliver and myself put forward the concept of neighbourhood groups working together to take responsibility for their patch of the catchment, with Barung coordinating between groups and actively promoting and demonstrating this neighbourhood approach.

The outcome of the meeting was that a steering committee was formed to start the new Baroon Pocket Catchment Care Group with representatives from the following community groups -

As the aim is to produce a Catchment Management Plan it is important that all community groups have input into the process. The assumption by Sci-Plan has been that if you take a list of relevant community groups who have a stakehold in the Baroon Pocket Catchment and allow each group to have a representative on the steering committee, then you will have a fair and broad cross section of the community having input into the process.

In reality this is not necessarily the case. As I see it, the challenge for the steering committee is to activate a process which will allow input from a more diverse cross section of the community than are currently on the steering committee. There was not a single woman on the committee and to me this was a glaring omission.

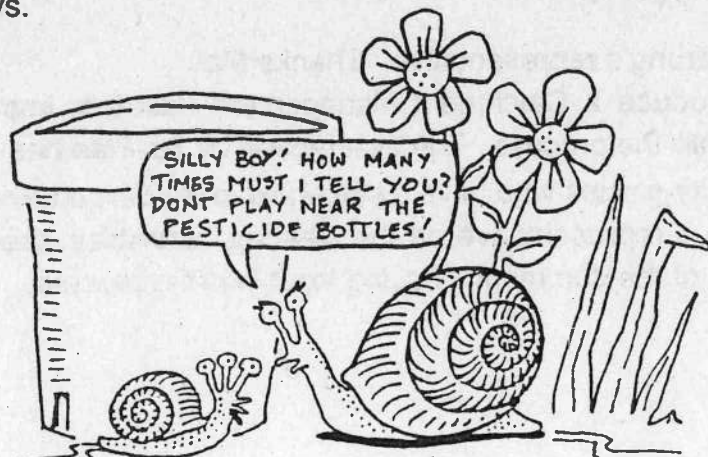

WATER QUALITY TESTING WORKSHOP

We are holding a water testing workshop as a follow up to The Mary River Congress. The workshop will be held at The Maleny High School on the 7th of November from 9.00am till 3.00pm and it is necessary for people to book as numbers are limited to 15.

If you wish to bring samples along and test them on the day then it will be necessary to organise to collect the sterilised jars.

The water samples need to be taken from the same body of water but in 4 different spots.

The cost of doing the tests (materials only) will be \$20.00. After doing the workshop you should feel totally capable with doing all your own tests at a later date.

The tests are

1. P.H.
2. Dissolved oxygen.
3. Phosphates.
4. Nitrates.
5. Total dissolved solids.
6. E-coli results after 24hrs.
7. Bio-chemical oxygen demand results after 5 days.

SCHOOLS NURSERY UPDATE.

On my last count 7 of the 8 schools in this project had their Shadehouses up and ready to go. Greening Australia provided another \$600.00 to be distributed between the 8 schools involved in this project. It was provided to allow each school to get a start up kit of pots, potting mix, fertiliser punnets and labels to get their project going.

Graeme Gibson from Greening Australia and I visited 4 of the schools - Montville, Palmwoods, Eudlo and Matthew Flinders Anglican College, to help them start their projects. We provided them with a variety of seeds and helped them to identify the project in their area which they wished to work on. It was a very interesting day to see just exactly what is going on in each school. Graeme and I hope to visit the other 4 schools before the end of the year.

CABINET TIMBER TRIALS ON THE RANGE



Dr. Mike Olsen from the Uni. of Qld. has been up in the Barung area looking for a trial site to do a cabinet timber plot. He wants to trial the difference between trees grown with grow tubes and trees without. Mike has already got a site at Mt. Mee and another at Canungra and he is using the information collected from these trials to determine which species would be most suitable for the Maleny/Montville trials.

We have had a look at a few different sites and seem to all be agreeable on the site at Western Ave., Montville. It is a good sloping protected site with good soil and is highly visible. We hope by making the site readily available to the public and by keeping people informed on its progress it may encourage more people/groups/ organisations to get into using trees. We hope the site will later be able to show the way in which trees can be used to :

1. Create an income in the future - cabinet timbers.
2. Create a buffer zone between different types of development.
3. Provide an effluent soak for the run-off from residential and/or commercial premises.
4. Help to create a wildlife corridor link for native birds & animals.

Barung is happy to help anybody who is interested in this sort of project and to put them in touch with the experts in this field. There is not a lot of information available on the returns from this type of project as most of the research has only been done over the last few years.

Also there is a Field Day being held at Mt. Mee to check out the Cabinet timber trial which was set up there a couple of years ago. It will be held on October the 10th at the property of D & J Pickering between 10am and 2pm.

EXPRESSION OF INTEREST

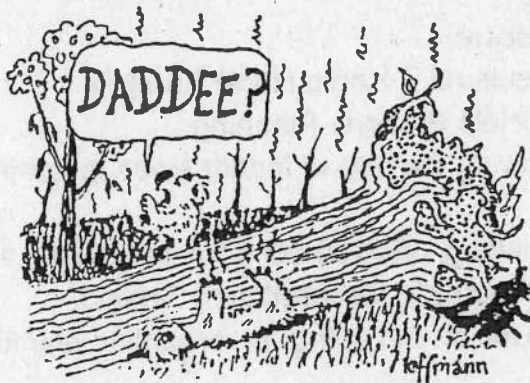

BARUNG LANDCARE RURAL SUBCOMMITTEE

The inaugural meeting of the Rural Subcommittee was held at the Enterprise Centre on 21.1.92. Committee members were Mal Thompson (President), Rob Cork (Secretary), Lexy Forbes (Coordinator), Kay Corkin, Bill Hall and Scott Kirby.

At that meeting the committee discussed the reasons for the formation of the group and came up with the following aims:-

1. Coordinate with existing farmers groups
2. Improve the image of Landcare with Rural Landholders
3. Generate a column in the Range News to alternate with Botany Watch
4. Encourage the use of organic fertilisers
5. Provide rational economic arguments in support of products and systems
6. Analyse products- (sprays, fertilisers etc)
7. Provide a balanced argument to the community on rural affairs
8. Investigate government funding available to rural landholders
9. Include the Forest Industry matters within our charter

Since that first meeting the committee has met regularly every month and we are well on the way to achieving in part our stated aims. Activities covered by the committee during the past eight months are as follows:-

5. In conjunction with the Botany Dept of (Uni of Qld) trying to organise planting of cabinet timbers in the area
6. Presented a workshop on " Pastoral Practices and Catchment Management " at the Inaugural Mary River Congress.
7. Actively trying to seek information about agricultural and horticultural runoff
8. Provide regular news brief for Range News
9. Help with Landcare exhibit at show
10. Liaise with Qld. Dairymans Organisation about forthcoming events which may be of interest to their members.

In the period of time the committee has been operational, we have witnessed a great deal of interest by rural landholders in the various subjects that we have pursued. We have had quite a few farmers attend our meetings and field trips. This augers well for the future of our committee and proof that Landcare issues cover a broad spectrum and appeal to a wide variety of people from all walks of life.
